4.2 EMD and participation fee are to be dealt with as per the procedure mentioned below: -

- 6.1 Bid received may be negotiated or re-invited, or an open auction may be conducted, if the need arises.
- 6.2 Any /All of the bids received may be rejected without assigning any reason.
- 6.3 This e-Auction Participation Form is to be signed and stamped on all pages after duly filled out. It should be submitted along with the requisite EMD and other Enclosures as specified in this form.
- 6.4 Disposal of the above material will be on 'As Is Where Is Basis', 'Whatever There Is' basis, and 'No Complaint' basis. The rule of 'Caveat Emptor' shall apply.
- 6.5 The inspection of the goods will be strictly on as is where basis is. The Participant will not insist on opening / breaking and/or testing of the items on sale.
- 6.6 The Participant shall not pick and choose and/or carry anything out of Seller's premises for inspection / testing or any other purpose.
- 6.7 The photographs shown in the website: [www.eauctioneer.in](http://www.eauctioneer.in) is only indicative. The Buyer must physically inspect the material at site and obtain necessary clarifications on all matters relating to items.
- 6.8 It would be assumed that Participants have inspected the above salvage and acquainted themselves with the offered goods available for purchase, whether they have actually inspected the same or not. However, it is expected that the Participants will inspect the salvage at the site before participating in Auction.
- 6.9 There will be no guarantee for quantity & quality of offered goods either by us or by the Seller, as material is being sold on '**As Is Where Is' and 'Whatever There Is'** basis.
- 6.10 Queries / clarifications, if any, should be addressed before the e-Auction. No queries / clarifications will be entertained after the e-Auction.

**6.13** The Buyer shall be solely responsible for any harm/loss of life or damage/loss to property caused due to use/consumption of the offered goods, purchased by him.

**6.14** The rule of ‘caveat emptor’ shall apply here. Therefore, the Buyer should inquire and fully familiarize themselves with all the limitations, rules, licenses required and regulations in respect of end use /consumption/further reselling of goods purchased.

**6.15** Kindly submit the Copies of Address Proof / Pan Card/ Vat/Sales Tax etc. certificates along with this Form.

**6.16** If need arises, the terms and conditions contained in this e-Auction participation form may be changed without notice. In case of any change, all efforts would be made to communicate the same to the interested participants at the earliest possible. However all the interested participants are advised to visit, and check latest information or any changes in terms and conditions, time, changes in items offered for sale, date etc. and the terms and conditions to which the e-Auction is subject to at the website [www.eauctioneer.in](http://www.eauctioneer.in).

## **7. FINAL PAYMENT & MATERIAL LIFTING / TRANSPORTATION**

**7.1** The Buyer shall make their own arrangements for lifting and transportation at their cost and Seller will not be liable or responsible for the same. All charges incidental to loading and lifting of material will be borne by the Buyer.

**7.2** Lifting is to be made as per instructions given by the Seller. For example, more damaged material to be lifted first etc.

**7.3** The Buyer shall not be allowed to pick or choose or segregate any particular item out of the lot sold by the Seller at the time of delivery of the lot. **The Buyer shall be bound to clear the entire lot as directed by the Seller on clean sweep basis.**

**7.4** The sale of offered goods is on single lot basis, however the materials are to be lifted on actual quantity basis (**Per kg/whole lot**).

**7.5** The Buyer shall ensure that while moving, lifting and/or removal of items on sale, safety rules is followed. Any litigation related to accidents/injury caused during the process would be taken care of by the Buyer who will be solely responsible for the same.

The Buyer shall remit **20% payment (Exclusive of EMD) within 3 working days from the date of acceptance of the Buyer's Offer. The balance payment would be made within 10 days, (except for salvage value exceeding 50 Lacs). The same shall be, as per the payment schedule in the name of M/s Playgro Toys India Pvt Ltd. by way of DD/Money Transfer. In case H1 bidder backs out or fails to fulfil payment / lifting conditions, the EMD of H1 bidder would be stand forfeited. In this case H2 bidder will be invited to lift the material or re-Auction would be carried out as the case may be. If H2 bidder fails to fulfil payment /lifting conditions, the EMD of H2 bidder would be forfeited too.**

**7.6** Only after depositing the 100% payment as mentioned above, the Seller shall issue a Delivery Order to the Buyer on receipt of which the latter shall be allowed to start the lifting of the material.

**7.7** The total lifting period shall not exceed **20 working days** or more as agreed later from the date of receipt of the Delivery Order, i.e. failing which:

- The Buyer shall pay to the Seller ground rent, as decided for the period in excess of the stipulated period; and/or,
- The Seller may dispose of the remaining lot at its discretion, at the risk and cost of the Buyer.


**7.8** Lifting of the materials belonging to various categories shall be made against advance payment on Quantity (**per kg/whole lot**).

- If the final salvage quantity comes out to be more than the estimated quantity, then the Buyer will immediately deposit by DD/Money Transfer/Cash the balance amount payable by him, after adjusting Earnest Money Deposited. At no time the delivery should be made for more than the amount deposited with **M/s Playgro Toys India Pvt Ltd.**
- If the final salvage quantity comes out to be less than the estimated quantity, then **M/s Playgro Toys India Pvt Ltd.** will refund the excess payment to the buyer within **5 working days of the clearance of the entire lot.**

**7.9** In the event of delayed acceptance of order for lifting and/or lifting of goods as stipulated above, in addition to forfeiture of the EMD, the Buyer will also be liable for any loss suffered by **"Select E Auctioneer Pvt. Ltd."**

**7.10** All documents like delivery challan, gate pass, etc. will be prepared in the name of the Buyer and/or their duly authorized representative.
